MLA do not guarantee that these risks or hazards will be removed or advised. You are advised to take extreme caution during any activity carried out in relation to motorcycle riding or participating as a pillion passenger on any tour arranged by MLA. You may be injured or even killed, your machinery or equipment may be damaged, lost, stolen or destroyed, others participants on this tour may ride dangerously, with lack of skill and may break road rules applicable to the country region you are riding in, the tracks and roads may be hazardous, there may be rocks, tree stumps, gullies, hills, jumps, ruts and bumps, livestock, river crossings and many other hazards and they and many other dangers are so numerous that there may not be warning signs indicating those dangers and they may vary without warning or predictability and that there may not be adequate facilities for treatment or transport if you are injured. Furthermore MLA does not have Public Liability Insurance and advise that under no circumstances will any financial assistance be made to you for loss or damage to you or your property. I accept that I will not be allowed to participate on this tour as a rider without a current motorcycle licence or personal travel insurance, copies which have been provided to MLA.
